Regarding the preservation of town records, Mr. Waugh asked how much it would cost to preserve each year's records annually once there is no longer a backlog. Mr. Atkinson will check with the Town Clerk.

In answer to questions regarding the budget for elections, Mr. Atkinson noted that all workers at the polls are paid an hourly wage, there are no volunteers. There must always be an equal number of Democrats and Republicans working at each election.

Budget item numbers 0600 (P.W. Highway) and 0601 (Paving) were discussed briefly but then tabled to be reconsidered at the next meeting (2/23/15).

Under discussion of 1300 Insurance, question was raised whether insurance has been put out to bid. Mr. Atkinson replied that this has not been done, noting that completing the required paperwork is very challenging and time consuming. He stated that currently all of the town's insurance programs are through Maine Municipal Association. Mr. Davis noted that other companies will consider insuring municipalities and someone would be able to help with the required paperwork. As he has a background in insurance, Mr. Davis will consult further with the selectmen.
