BUILDING PERMIT FEES

CONSTRUCTION COST/1000 x 7.50 = PERMIT FEE MINIMUM FEE - \$75.00

Ranch	\$110/sq. ft.	Cape	\$110/sq. ft.
2 nd floor	\$ 90/sq. ft.	2 nd floor unfinished	\$ 60/sq. ft.
Finished attic	\$ 30/sq. ft.	Garage on slab	\$ 30/sq. ft.
Finished basement	\$ 15/sq. ft.	Deck	\$ 15/ sq. ft.
Enclosed deck or porch	\$ 15/ sq. ft.	Shed	\$25/ sq. ft.

EXAMPLE – 1200 SQ FT RANCH, 30 SQ FT DECK, 900 SQ FT GARAGE, 1200 SQ FT FINISHED BASEMENT =

$\$110 \times 1200 = \$132,000$ VALUE (RANCH) - $\$15 \times 30 = \450.00 VALUE (DECK)

$\$30 \times 900 = \$27,000$ VALUE (GARAGE) - $\$15 \times 1200 = \$18,000.00$ VALUE (BASEMENT)

$\$132,000 + \$450 + \$27,000 + \$18,000 = \$177,450.00$ TOTAL VALUE

$\$177,450.00 / 1000 = 177.45$ $177.45 \times 7.50 = \$1,330.875$

Building Permit fee = \$ 1,330.88

BUILDING APPLICATIONS MUST BE FILLED IN COMPLETELY, ADDRESS, TELEPHONE NUMBER, MAP/LOT, INCLUDE PLOT PLAN SHOWING, SITE PLAN, BUILDING PLANS SHOWING DIMENSIONS, SIZES AND MATERIALS. EVERY LINE MUST BE FILLED OUT. SCALE DRAWING OF THE PROPOSED NEW, ALTERED OR RELOCATED BUILDING, OR THE REPLACEMENT CONTEMPLATED. THESE SUBMISSIONS WILL BECOME PART OF THE APPLICATION. APPLICATIONS WILL NOT BE REVIEWED UNTIL APPLICATION IS COMPLETE.

ELECTRICAL PERMIT FEES

Basic - \$35.00 New construction or rehab \$75.00

ALL PORTIONS MUST BE FILLED OUT, INCLUDING ELECTRICIAN AND LICENSE NUMBER. APPLICATIONS WILL NOT BE REVIEWED UNTIL APPLICATION IS COMPLETE.

PLUMBING PERMIT FEES

\$ 10.00/ fixture Minimum fee \$40.00 Permit transfer \$10.00

ALL PORTIONS MUST BE FILLED OUT, INCLUDING PLUMBER AND LICENSE NUMBER. APPLICATIONS WILL NOT BE REVIEWED UNTIL APPLICATION IS COMPLETE.

SEPTIC PERMIT FEES

Non-engineered system \$250.00 + DEP FEE \$15.00 (TOTAL \$265.00)

Replacement disposal field \$150.00 Other fees per state code

MISCELLANEOUS PERMIT FEES

Demolition \$50.00 Need DEP Building Demolition Form completed before issuance of demolition permit

Driveway \$15.00 Road commissioner approval or State Permit required before permit issued

Growth Permit \$500.00 Must be completely filled out

Home Occupation \$75.00 Must be completely filled out
