In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Hollis qualified by law to vote In Town affairs that a Special Town Meeting will be held at the Community Building in said Town on Wednesday, the twenty-ninth day of September 2021 A. D. (September 29, 2021) at 7:15 PM in the evening for the purpose of acting on the following Articles:

ARTICLE 1: To elect a Moderator to preside at said meeting.

ARTICLE 2: Shall the Town vote to authorize the Select Board and Tax Collector to amend Article 13, Item 1 from the Annual Town Meeting held on June 8, 2021 to charge interest on unpaid taxes, determine the rate thereon, set the due dates for taxes, and to set the date on which interest commences (Tax Collector charging interest at a rate of 6% per annum, that taxes be due and payable in two (2) payments). Change the first half tax due date from November 3, 2021, to December 8, 2021, with interest to commence on the first half on December 22, 2021, at 6% per annum. The second half due on May 4, 2022, with interest to commence on May 18, 2022 at 6% per annum.
