*The candidates are responsible for collecting certified nomination papers from the Registrar of Voters and delivering them to MSAD 6 Central Office by the deadline.*

**ELECTION DAY:  
TUESDAY, JUNE 11, 2024**

All voters may vote in their town for *all* vacant at-large MSAD 6 Director seats, regardless of the residency requirement for each vacant seat.
